1. The goal of the NPS 1:1 iPad program is to....
 - a. Use technology to supplement learning in the classroom
 - b. Efficiently find information and create projects that demonstrate learning
 - c. Speed up the feedback loop between teacher-to-student and student-to-student
 - d. Learn how to use technology responsibility

2. Use of CPS Internet:
 - a. There is great power and responsibility when using the Internet. Students should ask a staff member if they are unsure about using a particular website.
 - b. We utilize a web browser watch system called GoGuardian. Teachers and Admin will be able to see any website that is visited by students using the CPS network.
 - c. Students are expected to only visit websites for learning and classroom assignments.
 - d. If a student continually visits inappropriate websites their CPS network privileges will be revoked for a time determined by the administration.

3. Responsibility for iPad
 - a. We must all care for our new materials so they last for years to come. iPads will stay on school grounds and be locked in a secure location at the end of each day.
 - b. Parents and students are responsible for any damage outside of normal wear and tear.
 - c. A fee schedule is listed here for reference:
 - i. Power Adapter: \$25
 - ii. Screen: \$50,
 - iii. Back Screen Cover: \$45,
 - iv. Keyboard: \$65,
 - v. Motherboard: \$115,
 - vi. Battery: \$45,
 - vii. Complete iPad: \$329.
